### SNOW REMOVAL - A CHANGE THIS YEAR

We have many new Homeowners/Renters again this year so we want to mention the guidelines for when the HOA will remove snow on sidewalks. Snow will be removed on the sidewalks in front of the HOA member's homes at ½ inch and 3 inches in the alleys. The HOA can opt to increase it to 1" if the ½" is not successful. Nature's Best will have earlier start times now, due to a dedicated crew that will serve our neighborhood. Claudia will be notified as to the start time after each snow event. Nature's Best will only plow once a day, so if it is currently snowing, they will plow once the snow stops, which may cause a later start time. Alley ways will be plowed in the late afternoon. This change should be helpful to those who shovel their driveways. And Nature's Best will continue to remove ice and use snow melt around the mailboxes.
