TDS & SPRINKLER/GREENWAY SCHEDULES

The company that is installing Cable around the neighborhood has done a lot of drilling & boring which has resulted in some disruption with both our water & electrical lines in Pleasant View. Nature's Best has been in contact with them. Claudia has the contact information for TDS with any issues that may occur when we turn on the sprinklers and TDS will be responsible for the cost of repair. Depending on weather and due for the need of checking sprinkler lines, the sprinklers will be turned on in stages and might be later May or June before they are all turned on. SPRING CLEANUP

- Now is the time to clean up around your property. That includes behind your fence if it is on an alley.
- It is the homeowner's responsibility to maintain the sidewalks in front of your home.
- Please remove any old flyers on the mailboxes.
- Dogs are required by the City to be on a leash when they are out. And please pick up any dog
 poop they may leave while out walking. The HOA has supplied bags & receptacles for this
 purpose, to keep our neighborhood looking its best.
- Our neighborhood has a healthy dandelion population. Digging them up doesn't seem to work and seems to stimulate growth. Take care with any weed control product.
- If you have a vehicle that is not working, it must be stored in the driveway and not parked on the street. They can be tagged if on the street and the City will remove them.

STREET LIGHTS

The boulevard lights belong to the HOA and we are responsible for maintaining them. Most of the time it is just a light blub that needs to be replaced but we are beginning to have some bigger issues with some of the lights that were installed in the 2000's. Where the wiring and lights were put in, some of that is now under sidewalks and driveways. These repairs are very expensive and not something the HOA can afford. For example, the bid to repair the 3 lights at Kingsbury, Saxony and Knightbridge is in excess of \$28,000. An alternative option we are looking into is solar lighting for those poles. RECREATIONAL VEHICLES: Utility Trailer, RV's, Boats, Rafts, Campers



According to the HOA covenants, these types of vehicles are only permitted to be on the street or in your driveway for not more than 48 hours. However, the City states for not more than 5 days. During that time, they are not permitted to block the sidewalk in any way and NEVER place an extension cord across the sidewalk. This a safety violation and can be reported to the City Police.
