Sidewalk and Alley Snow Removal

Just a reminder that snow will be removed on sidewalks in front of HOA member homes at 2 inches, 2 inches on HOA owned sidewalks and 4 inches on the alleys. Snow accumulation amounts are typically not the same around our neighborhood. An effort is made to average the different snow depths. PLEASE NOTE that HOA is only responsible for maintaining HOA-owned sidewalks. Snow and ice removal ultimately is the responsibility of the homeowner, and the alleys are maintained by the City. The HOA provides these services to its member as an extra benefit when the HOA budget allows for it.
